## CITY OF COLD LAKE BYLAW NO. 838-AN-24 2024 TAX RATE BYLAW

A BYLAW OF THE CITY OF COLD LAKE, IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY FOR THE 2024 TAXATION YEAR.

**WHEREAS** the City of Cold Lake has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the Council meeting held on December 12, 2023;

**AND WHEREAS** the estimated municipal expenditures and transfers set out in the budget for the City of Cold Lake for 2024 total \$58,011,249.00 and;

**WHEREAS** the estimated revenues and transfers from all sources other than taxation is estimated at \$34,564,819.67 and the balance of \$23,446,429.33 is to be raised by general municipal taxation, and;

**WHEREAS** the Council of the City of Cold Lake is required each year to levy on the assessed value of all property tax rates sufficient to meet the estimated expenditures and requisitions, and;

**WHEREAS** the Council is authorized to classify assessed property and to establish different rates of taxation in respect to each class of property, subject to the *Municipal Government Act*, Chapter M-26, Revised Statutes of Alberta, 2000, and Order of Council 356/2018 for Annexed Land and,

**WHEREAS** the assessed value of all taxable and GIL property in the City of Cold Lake as shown on the assessment roll is:
