

## MUNICIPAL ELECTION 2025 FLECTION WORKER APPLICATION

As an Election Worker, you will assist with the set-up and closure of the voting station as directed by the Returning Officer or Presiding Deputy, ensure electors have the required authorized identification to vote, issue and process Form 13 (Elector Register), complete all documentation and worksheets required for electors to cast their vote, direct voters to voting station, and any other duties as required by the Returning Officer or Presiding Deputy.

In order to qualify for this position:

- You must be a minimum of 18 years of age and are eligible to work in Canada.
- Willing to work long hours and be able to either sit or stand for long periods of time.
- You demonstrate knowledge of election processes.
- Have strong organizational and communication skills.
- Possess a strong attention to detail.
- Be able to lift boxes up to 40 pounds.
- Demonstrate the ability to deal tactfully and courteously with the public and work in a fast-paced, stressful environment.
- Previous experience as an election worker is an asset.

Preference may be given to applicants who are available on all polling dates and times. Applicants must have their own transportation. Election workers must attend one of the mandatory training sessions held on Friday, September 19, 2025, or Friday, September 26, 2025, (City Hall Council Chambers) from 2:00pm- 4:30pm (\*if you are unable to attend either of these sessions, please do not apply for the position).

The hourly wage for this position will be \$22.00 per hour. Deadline to submit application is August 26, 2025. The City of Cold Lake thanks all applicants for their interest; however, only those selected for an interview will be contacted.
