A BYLAW OF THE CITY OF COLD LAKE, IN THE PROVINCE OF ALBERTA, TO PROVIDE FOR FINANCE ADMINISTATIVE FEES

**PURSUANT** to Section 7(f) of the *Municipal Government Act RSA 2000, Chapter M-26*, Council may pass bylaws for municipal purposes respecting services provided by or on behalf of the municipality;

**WHEREAS** Council wishes to charge administrative fees for particular finance administrative services provided by the City of Cold Lake;

**NOW THEREFORE** the Council of the City of Cold Lake in the Province of Alberta, in Council duly assembled, hereby enacts as follows:

#### **SECTION 1 - TITLE**

1.1 This Bylaw shall be cited as the "Finance Administrative Service Fees Bylaw".

# **SECTION 2 – ADMINISTRATIVE SERVICE FEES**

- 2.1 The City of Cold Lake may charge fees for the provision of various finance administrative services in accordance with Schedule "A" of this Bylaw.
